- Prospect Park Subcommittee Recommendation Report- Peterson gave a brief recap of the subcommittees recommendations for the Parks Director in regards to Prospect Park. Per The Advisory Board By-Laws

SECTION 1.0 OFFICERS

1 Officers

1.1a Chairperson

- 1. The position of Chairperson is hereby established.
- The Chairperson shall set the agenda and preside at all Board meetings.
- The Chairperson shall have general charge of the business of the Board.
- The Chairperson shall appoint all Committees.

1.1b Vice Chairperson

- The position of Vice Chairperson is hereby established
- The Vice Chairperson shall act in the capacity of the Chairperson in the absence of the Chairperson.
- In the event the office of the Chairperson becomes vacant, the Vice Chairperson shall accede to the office for the unexpired term, and the Board shall elect a successor to the office of Vice Chairperson for the unexpired term.

1.1c Secretary

- The position of Secretary is hereby established.
- The Secretary shall attend all regular and special 2. meetings.
- 3. The Secretary shall work in concert with department staff to present a record of those meetings to the Board, and to the Mayor and City Council.

1.2 Board Elections

- 1.2a The Chairperson of the Board shall be elected at the annual meeting of the Board and shall hold office for one
- 1.2b The Vice Chairperson shall be elected at the annual meeting of the Board immediately after the Chairperson and shall hold office for one year.



1.2c The Secretary shall be elected at the annual meeting of the Board immediately after the Vice Chairperson and shall hold office for one year.

1.2d Any vacancy in the office of Chairperson, Vice Chairperson or Secretary of the Board may be filled at any regular or special meeting after such vacancy.

1.2e The Board shall elect a liaison to attend the meetings of the Riverfront Improvement Commission and shall serve in this capacity for one year. The liaison shall report to the Board at the regular monthly meetings.

Park Advisory Board members that have voiced interest in an elected position:

- McBride- Chairperson or Riverfront Commission Liaison
- Peterson- An elected position, no specific position listed
- Schertz- Chairperson or Vice Chair or Riverfront Liaison
- Spratt- Secretary
- Trees- Chairperson

Order of operation for officer elections:

- Board discussion
- Move to nominate a specific individual
- Movement 2nd
- Final discussion
- \bullet Vote, must have 50% or more of total number of voting members. In the event of a tie discussion will continue, followed by a $2^{\rm nd}$ vote

This process will be repeated for each elected position.
