# Park and Recreation Advisory Board October 19, 2023 Staff Report

## Notable updates from Staff

## Park Operations

- Fejervary Learning Center holiday lights were installed on a beautiful, warm, Fall day. Behind the scenes work continues, but the show will be ready for public viewing in late November. Staff will be installing lights at Vander Veer Botanical Park early November.
- Staff is working hard to winterize the almost 90 water sites within the Parks system. We close them in the reverse order of opening so the most popular locations are open the longest. The goal is to have all locations winterized by Halloween.
- Grass is still growing, so staff is still mowing!
- Proposals for Cork Hill and Monroe Park playgrounds were accepted. Installation will be in the Spring.
- Staff is working hard in conjunction with contractors and volunteers to ensure Veteran's Memorial Park is ready for the opening on November 2.

## Recreation

- Daniel Sheridan did a presentation on Performing Arts and Creating Culture in Programs for the Fall Iowa Parks and Recreation Association Conference.
- Taylor Schneider helped plan and execute the 2023 Bi-CAN (Bi-State Conservation Action Network) all member meeting at Niabi Zoo.
- We took 32 athletes to the Special Olympics State Volleyball competition on Sept 30<sup>th</sup> in West Des Moines. Our teams ranged in skill level from Division 1 players to Developmental/Skills Players. We took home 1 gold medal, 2 bronze medals, and 1 green medal (4<sup>th</sup> place). 5 of our skills players each were awarded gold medals!
- On Saturday, September 23 residents from all over the Quad Cities and visitors in advance of Sunday's QC Marathon took part G.O.A.T. (Get Out and Trail) a celebration and exploration of QC trails. Participants were able to explore trails on both sides of the river as pedestrians or cyclists

and visit hosted stops to learn more about the local area and agencies, win prizes, and enter raffles. This event was in collaborative partnership with City of Davenport Parks and Recreation, City of Bettendorf Parks and Recreation, City of Moline Parks and Recreation, City of Rock Island Parks and Recreation, City of Riverdale Parks and Recreation, City of Port Byron, Bi-State Regional Commission, Quad City Health Initiative, Visit Quad Cities, and Community Health Care, Inc.
