## 46th St and Eastern Avenue Park Project

Northeast Davenport has always been underserved by park facilities since development started back in the 1970's. There are no park facilities that serve the northeast part of the city from Brady Street to Elmore Road and from Kimberly Road to 53rd Street (see maps 1 & 2). This is the **largest and most populous** residential area of the city that lacks park facilities and without reasonable access to any park facilities. A park within this area would serve the residents of the 6th, 7th and 8th Wards (see map 3).

The property located at 46th St. and Eastern Avenue is a cornfield owned by the Davenport School District and is now for sale. This creates an opportunity to fill a void that has been present in Davenport since development began in the northeast part of the city, and if missed, will **FOREVER** leave this area of the city without a park facility. If the need for a park in the area is doubted, just drive through the streets during a nice day, any day of the week, and you will see neighbors using the streets as recreational facilities.

The closest park to this area (nearest entrance .8 miles from 46th St and Eastern) is Prairie Heights north of 53rd Street. This is an underdeveloped park with mainly a few ball diamonds for facilities. The next closest park is Eastern Avenue park located at 29th St. and Eastern Avenue (1.1 miles from 46th and Eastern Ave). This too has very limited facilities and mainly serves as an entrance to the Duck Creek recreational path.

Neither park is accessible **SAFELY** by foot or bicycle. Traveling by foot or bicycle requires; traveling on shoulders of main traffic arteries (Eastern Av., Jersey Ridge Rd.) which lack sidewalks in many areas; where sidewalks are missing, the shoulders are unimproved; and both require crossing major streets (E. 53rd St, Kimberly Rd, Eastern Av, and Jersey Ridge Rd.) from any area that is not immediately adjacent to the parks. Children as well as adults living south of 53rd St and north of E. Kimberly Road can only safely access the parks by car.

The area of 46th St. and Eastern Avenue presents the last open ground in a residential area East of Brady St. to Elmore Avenue, south of 53rd St and north Kimberly Rd that would be large enough and reasonably contoured to accommodate a park. The homeowners of Windsor Crest, Windsor Crest North and adjacent homeowners are urging the City of Davenport and the Davenport School District to collaborate in an effort to create a passive neighborhood park at this location.

We envision the area as a passive park, one that would have walking paths, open space, an open shelter, possible dog park and minor playground equipment. The idea is a park requiring minimal maintenance and usable by as many residents as possible.

There is **urgency** in this request because the School District has placed the property for sale. We urge officials to seek funding by any means available, whether it be state, federal or local funds, to purchase this ground and develop a park that will enhance the beauty and desirability of living in Davenport. Quality of life is a major factor for retaining and attracting people to a city and at the top of everyone's list is availability of recreational facilities. Please give this request serious consideration.

To summarize:

1. We support the City of Davenport purchasing the area of 46th St and Eastern Avenue, currently owned by the Davenport School District, to create a passive neighborhood park.

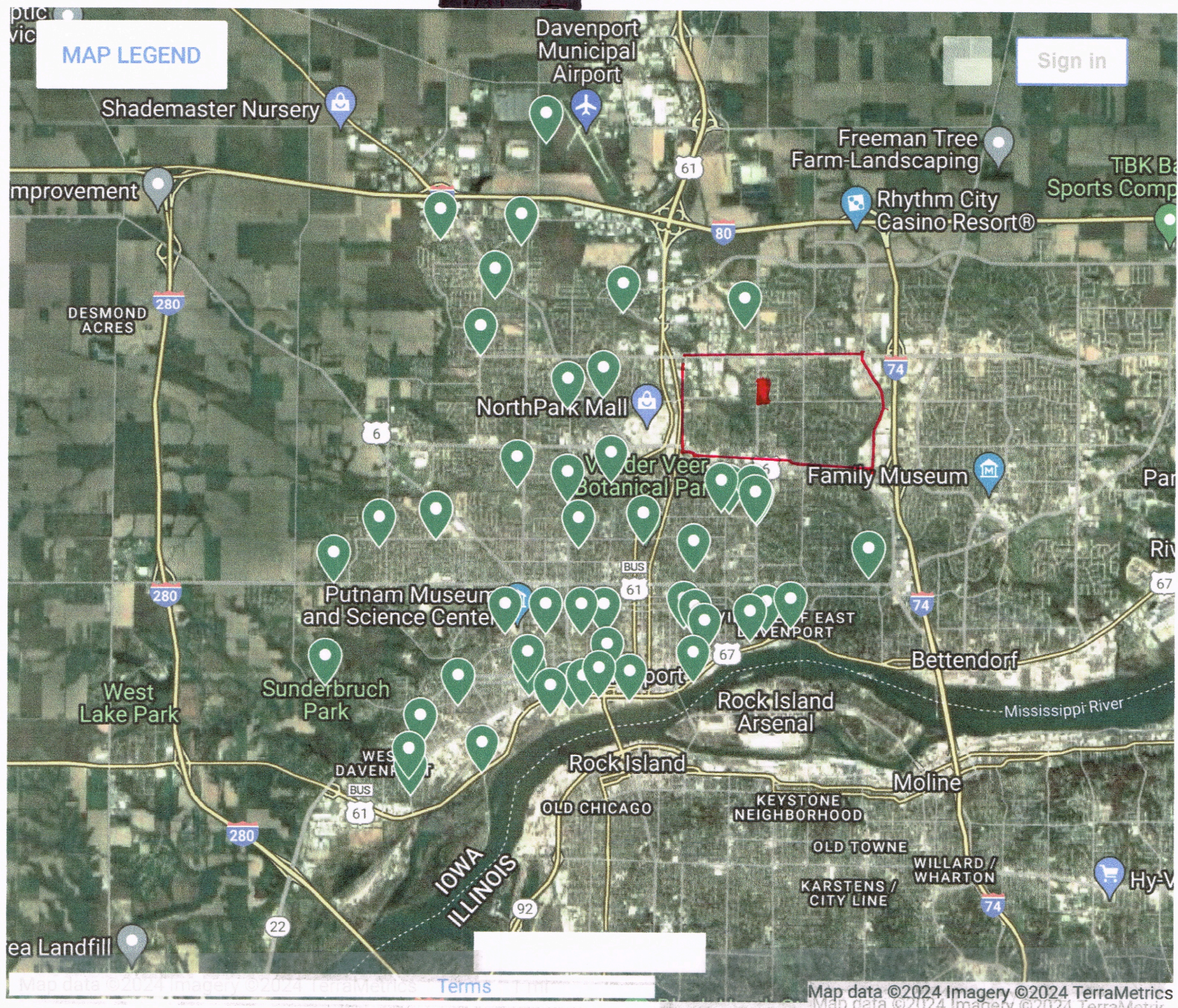


2. We encourage City staff to apply for State of Iowa, Federal or local funds or available recreational grants to fund the purchase and development of the park.
3. We envision a passive park with walking trails, open ground, an open shelter, possible dog park and minor playground equipment, nothing requiring high maintenance or operating costs.
4. The park facilities closest to the area (Prairie Heights Park and Eastern Ave. Park) are **dangerous** to access by foot or bicycle because the roads leading to the parks lack sidewalks, require crossing high speed major roads and the long distance to the parks. This renders them unusable to children in the area and most adults unless they drive to the parks.
5. This area of Northeast Davenport is the largest residential area in Davenport without park facilities that can be safely accessed by foot or bicycle. Wards 6, 7 and 8 are directly affected by this oversight.
6. Windsor Crest, a major subdivision of the city, was built without sidewalks or any open area. Numerous residents enjoy walking but are forced to walk in the streets and do not have the enjoyment of a park or open space for any other physical activity or gathering space.
7. This is the last open ground in this area of Davenport that could support a park facility and would be an opportunity **lost forever** if we fail to act.

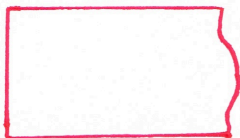

- proposed park at E. 46th St and Eastern Avenue



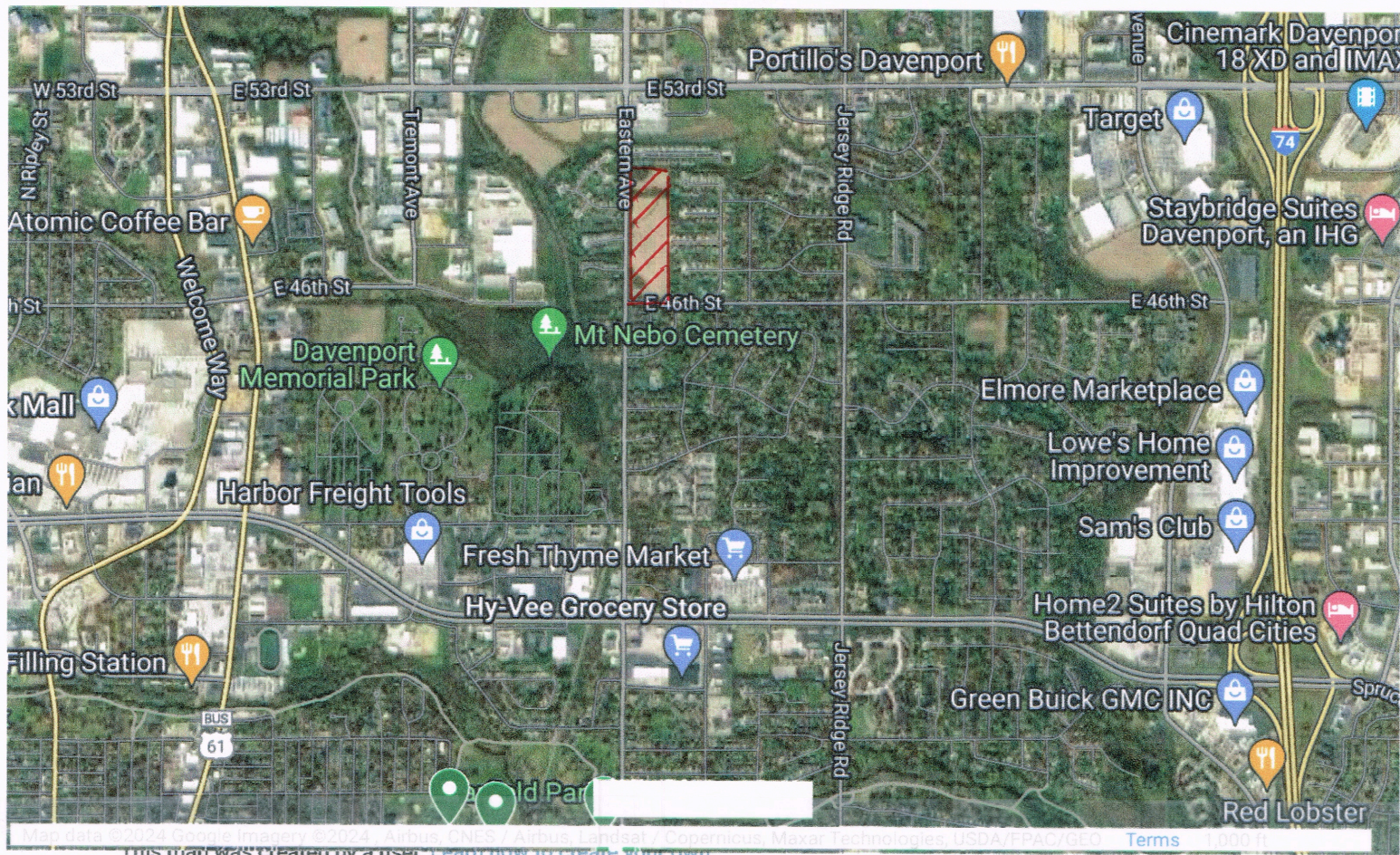
- largest residential area in Davenport without park facilities

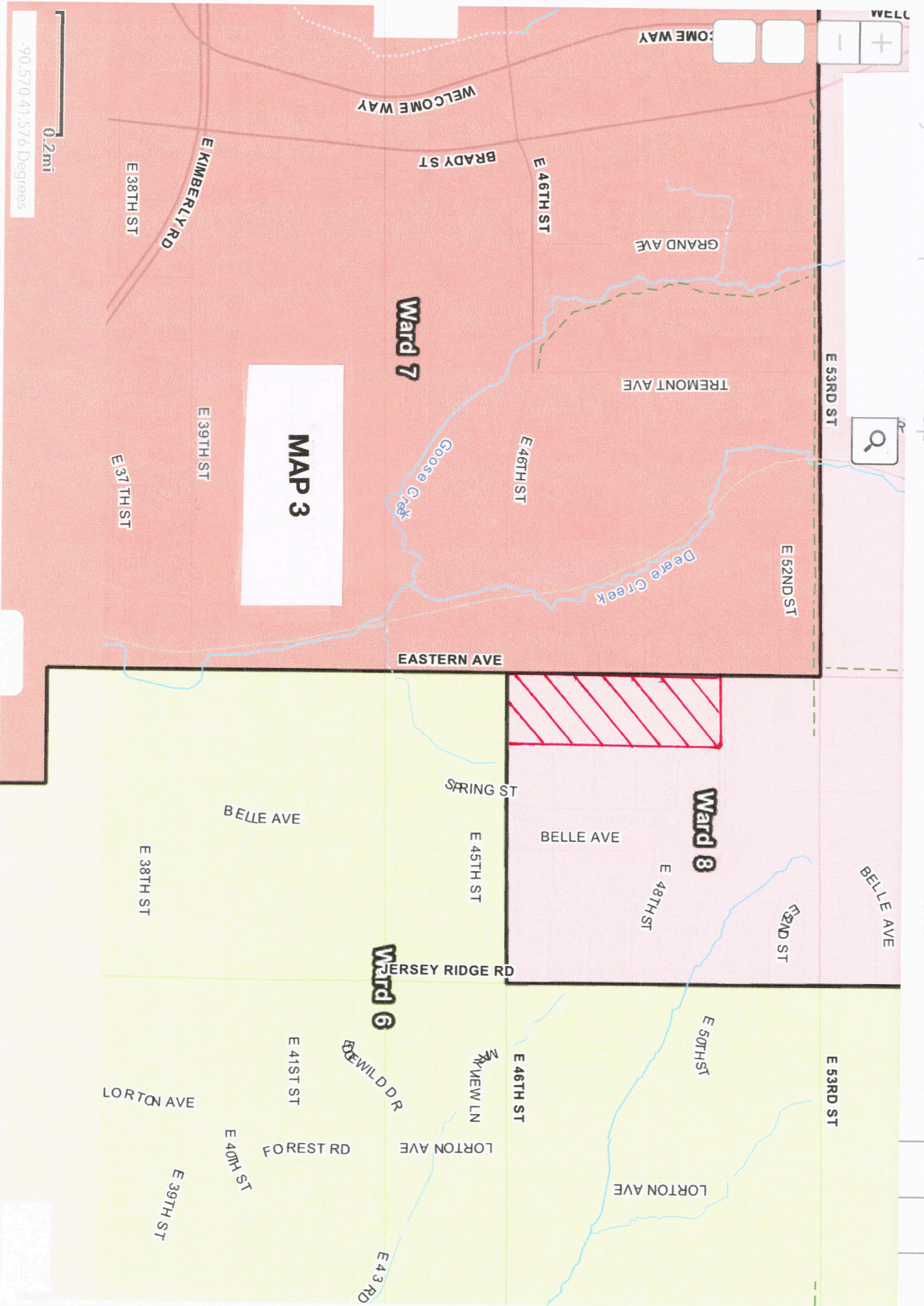

We are Julie and Lon Wilken, 1961 E. 50th St. Court, Davenport. I am writing to request your support in a significant project for Northeast Davenport. Our neighbors in the area are requesting the City and the Davenport School District join together to create a park on the open ground at 46th and Eastern Avenue.

Park facilities have always been underserved in northeast Davenport since development started in the 1970s. 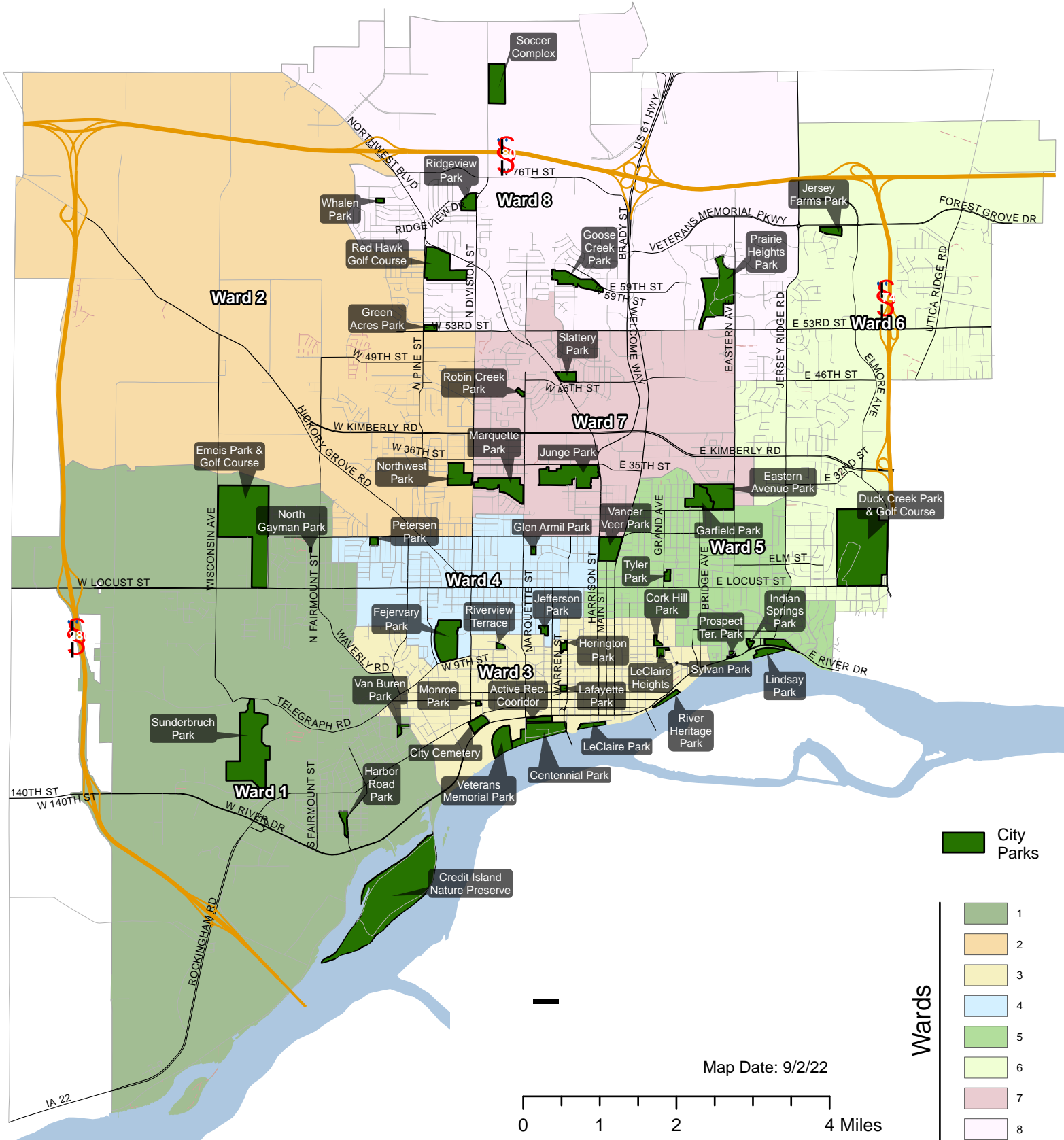

## ANALYSIS

The LOS for Davenport's system was initially calculated based on the previous NRPA standard (10 acres/1,000 residents) in order to gain a baseline understanding of the system. A detailed assessment of the parks and open space available to residents provides an understanding of the opportunities that might be available within the community for development of other recreational amenities.

To support the LOS analysis, the service radius for parks in Davenport were delineated to illustrate coverage and help quickly identify potential service gaps. The maps on the following pages indicate service radius by type and collectively.

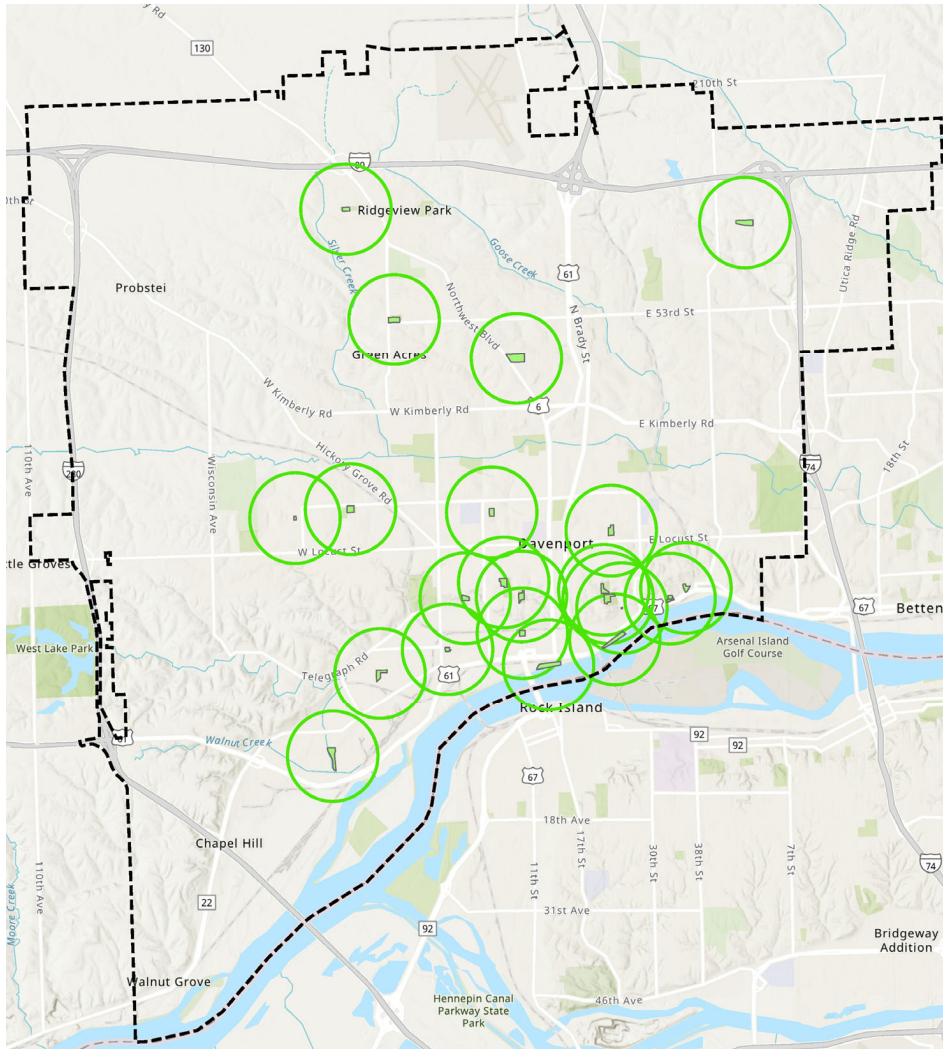
## SUMMARY

Level of Service (LOS) is a metric-based expression of the minimum recreation and park infrastructure capacity required to satisfy the needs of residents of the community. Agencies track LOS as a way to meet the desires of the community and maintain a desired state while taking into consideration limited financial and human resources.

The LOS analysis considers only those facilities and parks within the limits of the planning area. Private or membership-based facilities are excluded from the analysis but should be considered by the agency when making decisions regarding expansion of services and facilities that might otherwise be served by these private or membership-based facilities.

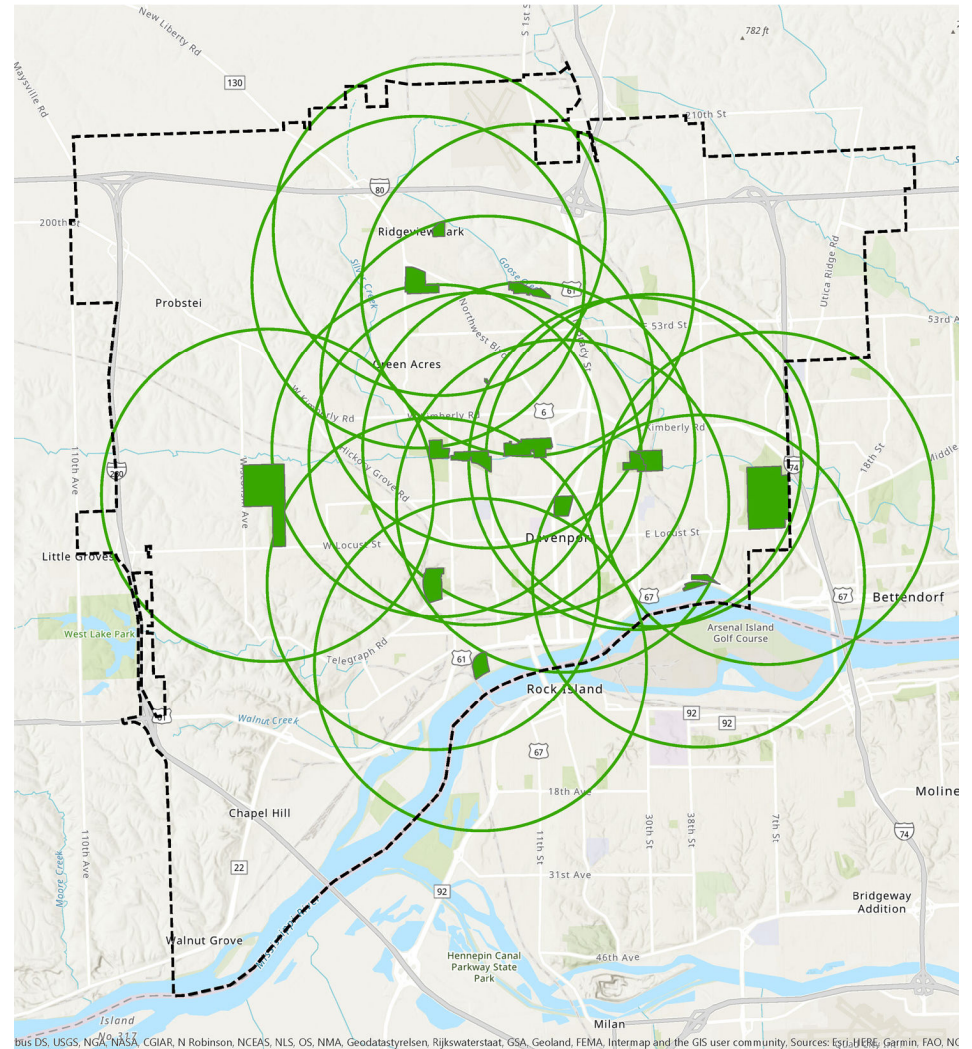
The existing LOS indicates the greatest need/deficiency is Neighborhood Parks.





## LOS: NEIGHBORHOOD PARKS

Neighborhood park distribution shows a concentration of neighborhood parks in the oldest neighborhoods with fewer parks in newer neighborhoods and undeveloped areas within the city limits. Service radius overlap in the older neighborhoods illustrates there is more than adequate facilities in those areas but the overall neighborhood service level is low elsewhere.



## LOS: COMMUNITY PARKS

Community park distribution show several community scale parks within the city limits with considerable overlap in their service radius. The Duck Creek corridor, running east and west, features five parks of significant size. This map illustrates a lack of community park facilities in the northwest, northeast and southwest corners of the city.

## Staff Report

### Notable updates from Staff

#### Administrative Services

- Dog Park update: new tunnel amenity was installed late December. With the nicer, more temperate weather the sod is holding up well under the straw laid on top. Four more agility/obstacle course style amenities will be installed this spring. New rules signs have been installed. The next step will be to develop and install smaller, fun educational-type signage, such as etiquette and tips/tricks.
- Staff are meeting with potential new sites to host AmeriCorps members for the 24/25 year. Possible new sites include Davenport Police Department's Community Impact Team, City of Davenport Administration division's Good Neighbor Project and Riverfront Improvement Commission, and Davenport Public Libraries.
- The new recreation management software, RecDesk, has been live since the beginning of January. Staff took a phased approach: 1) transition all 2024 facility reservations, which has proven very successful; 2) adding all spring and summer recreation programs in time for the mid-February/early March enrollment time frame; 3) onboarding all Point-of-Sale items for The River's Edge and aquatic centers. For day-to-day operations and financial transactions, staff anticipate the full transition to be complete by mid-March.

#### Park Operations

- Construction on Dohse Splash Pad has started.
- Staff has been busy prepping the pools for spring. Old heating systems have been removed, and walls have been prepped for a fresh coat of paint.
- Staff has been addressing vandalism issues at River Heritage Park, where lighting was stripped of wiring, the Skate Park where lighting and camera systems were destroyed, and the basketball courts at Centennial where the electric panel was pulled from its base.

- Tree trimming along the Duck Creek Recreational Trail has started with the goal to remove any dangerously low branches or vegetation that could interfere with the use to the trail.
- A full-time custodian position has been posted, applicants have tested, and interviews are scheduled for February 15.

## Recreation

- Environmental Classes “Native Landscapes Garden Planning” and “Winter warmup Natural Teas” had good turnouts.
- The 3<sup>rd</sup> and 4<sup>th</sup> weekends of February and March, staff is partnering with Living, Lands, and Waters to do the annual Tree-Wrap-A-Thon for their Million Trees Project.
- Staff and AmeriCorps members helped to recruit volunteer buddies and agency guest registration for Night to Shine, for the over 500 buddies and 385 of the 550 guests we coordinated.
- Staff have started recruiting for summer positions and aquatics has already had 42 applicants, of which 24 are returning lifeguards. Sadly, staff had to cancel the first round of open interviews due to weather conditions, but has many more scheduled events.
- Staff has kicked off a successful start to youth basketball, and is currently taking late registrations for spring soccer.
- Junior Theatre has over 470 registrations for spring session and trending to surpass last year’s numbers.
- Department and Junior Theatre staff hosted a community input session, with over 150 attendees, to gather feedback from users and supporters of Davenport Junior Theatre on ways to move forward for a long-term facility.

## Golf Operations

- Staff are grinding reels and performing winter maintenance on mowing machines and renovating signs and markings.
- Staff aided the department during the major snow event in late January to clear parking lots and trails.
